Introducing Co-Op IDCheck:

Enhanced Security for Shared Branching!

We're introducing **Co-Op IDCheck**, a new feature designed to add an extra layer of protection to your credit union transactions. This innovative tool verifies your identity quickly and securely at any Shared Branch location, providing you with safer and faster service every time you visit.

What You Need:

- Smart device
- Government-issued ID

How It Works:

1. Scan the **QR code** at the branch.
2. Type in **Greater Pittsburgh FCU** and select from the dropdown.
3. Provide your **shared branching account number** and the last four digits of your SSN.
4. Snap photos of your ID and take a quick selfie.
5. Receive a **verification code** — good for 20 minutes — to complete your transaction.

If you're unable to use IDCheck, don't worry. Traditional verification methods are still available but may have some limitations.

Upcoming Changes to Regulation CC — What You Need to Know

Starting July 1, 2025, updates to Regulation CC will change how quickly you can access funds from check deposits. These adjustments — made every five years under the Dodd-Frank Act to account for inflation — will impact next-day availability and cash withdrawals.

What's Changing?

- **Next-Day Availability Increase:** The minimum amount available for withdrawal the next business day rises from \$225 to \$275.
 - **Funds Access:** The first \$275 will be available the next business day after your deposit; the remainder will follow after standard hold periods.
- Why It Matters: Greater Pittsburgh FCU is updating systems, policies, and disclosures to ensure a smooth transition for all members. For complete details, please see our Funds Availability Policy or Truth-in-Savings disclosure.

Protecting Our Seniors: Elder Abuse Awareness Month

June is Elder Abuse Awareness Month, with June 15th marking World Elder Abuse Awareness Day (WEAAD). As financial scams targeting seniors continue to rise, staying vigilant and informed is crucial. Protect yourself and your loved ones from fraudsters who exploit trust and technology to steal hard-earned savings.



Common Scams Targeting Seniors

Tech Support & Computer Takeovers: There are many ways that scammers try to convince you to allow access to your computer—once in, they can do anything they want at that point. Scammers claim your computer has a virus and request remote access. Once inside, they steal personal information or trick you into sending money. Never grant access to your computer unless you initiated the call with a trusted tech provider. NEVER CLICK ON LINKS IN YOUR EMAIL THAT YOU WERE NOT EXPECTING.

Imposter Scams: Scammers pose as government officials, banks, or family members to demand payments. If you receive a suspicious request, hang up immediately, do not auto-re-dial, and look up the institution's phone number to verify the claim. Never send money to an account you did not open yourself—no one should be opening accounts in your name.

Gift Card Scams: No legitimate company or institution will ask for payment by gift cards not expressly for that company. Scammers will request codes from the back of gift cards as a means of payment—this is always a scam. Gift cards should only be used at the store or institution they are intended for. Never send money to someone you have not met in person.

Crypto & Precious Metals Buying Scams: Fraudsters pose as financial planners or investors, convincing victims to send money for reinvestment. Once funds are transferred, they disappear. Be cautious when dealing with cryptocurrency or precious metal investments from unfamiliar sources. Contact CFTC (Commodity Futures Trading Commission) to check the registration of any company trying to sell you precious metals at (866) 366-2382.

Wire Transfer Scams: Be extremely wary of requests to wire funds. Wire transfers are the least secure way to send money, as they are nearly impossible to recover once sent. Always confirm large transfers directly with the receiving institution before proceeding.

Protect Yourself & Loved Ones

Be Skeptical: If something sounds too good to be true, it probably is. Always verify suspicious calls, emails, or financial requests.

Monitor Accounts Regularly: Check your bank statements for unusual transactions and set up alerts for suspicious activity.

Verify Before Sending Money: If an institution or individual asks you for an unexpected payment, STOP, hang up, and verify their identity by calling the official number found online.
